Abstract

Pradhan Mantri Vishwakarma Yojana has been launched by the Prime Minister to benefit more than 140 castes in the country. More than 17 types of artisans working in traditional ways are participating in this scheme. This scheme was launched on 17th September 2023 on the birth anniversary of Vishwakarma. People between the age group of 18 to 50 can participate in this scheme. Under this scheme, each beneficiary is getting a loan of Rs. 3 lakh at a rate of 5% from the government, and the beneficiary is also getting Rs. 15000 from the government for the purchase of relevant artisan skill tools. The beneficiaries of each scheme are also given free training in relevant skill-based profession by the government. The forms of Pradhan Mantri Vishwakarma Yojana are filled online. For this, the website <https://pmvishwakarma.gov.in> is used. No end date has been given for this scheme. Participation in this scheme till the year 2027- 2028 is possible.

The scheme provides incentives for skill category improvement tools, digital transactions and marketing assistance to benefit every needy and poor class with the aim of improving the economic condition of the poor citizens. The Ministry of Micro, Small and Medium Enterprises is the nodal ministry of the Pradhan Mantri Vishwakarma Yojana, to help people with traditional crafts and to keep alive the old traditions and diverse heritage through local products arts and crafts. It is an important activity.

The First such training program was launched earlier this month on the 6th of November 2023 in Delhi-NCR, in collaboration with NIESBUD, and then Five day residential training program will be conducted at the Indian institute for Entrepreneurship (IIE) from November 15th to 19th, 2023 and will train 65 master trainers from 6 different states, including Assam, Bihar, MP, West Bengal, Tripura and Odisha. Scheme aims to support these craftsmen with better and more modern tools as well as to make their work more efficient. The training & financial aid provided to these workers will help bridge the gap between conventional arts & modern technology. The inclusion of such a wide variety of arts & crafts in the scheme aligns with the Indian ones of unity in diversity of different art forms under the same umbrella. Most artisans are Dalit, Tribals, Backward communities or rural women whose mobility is restricted due to social or cultural norms. Through this plan, Guru Shishya tradition can be seen. It helps to increase the quality & product service.

Due to this Vishwakarma Yojana of the Government of India, the traditional businesses run by people have started to be established again with a new vigor and the skilled artisans are getting the opportunity to use their skills properly under Pradhan Mantri Vishwakarma Yojana.

The training provided under the scheme is completely free, and the trainee is paid five hundred rupees a day during the training and 15 thousand rupees are given for the purchase of tools through Pradhan Mantri Vishwakarma Yojana the to provide Pradhan Mantri Vishwakarma Yojana was launched on September 17, 2023, the birth anniversary of Vishwakarma self-employment to artisans of different castes. No, neither a government employee, nor anyone in his family can apply for PM Vishwakarma Yojana in addition to the above mentioned benefits, the Scheme will onboard the beneficiaries on Udyam Assist Platform as 'entrepreneurs' in the formal MSME ecosystem. "This scheme aims to revive traditional industries through modern training, and attempts are made to make the traditional and skill-based artisans who are disappearing into employment and self-reliant."

"In Maharashtra, more than 60 thousand people are being trained under the scheme, more than 700 districts of the country, 250 lakh gram panchayats of the country are promoting the campaign, eight lakh artisans are being trained under the scheme."

Goal

Who can apply

A person who is an Indian citizen can apply for this scheme For this scheme 140 castes such as Blacksmith, Goldsmith, Chambhar, Both, Tailor, Sculptor, Carpenter, Agricultural implement maker, Gardener, Broom, Mat maker are covered under the scheme.

Applicants are Indian Citizens between 18 to 50 years of age.

Such beneficiaries can avail this scheme who belong to Vishwakarma Samaj.

18 types of traditional businesses are getting loans under this scheme.

Eligibility criteria: For Pradhan Mantri Vishwakarma Yojana (PMVY)

To apply in Vishwakarma Yojana, applicant's Aadhaar Card, Mobile Number, Caste Certificate, Resident Certificate, Passport Size Photo, Bank Account Passbook, etc. are required.

The minimum age of the applicant should be 18 years on the date of registration.

The applicant should be and craft person engaged in anyone of the 18 specified family best traditional trades organised informal sector.

The registration and benefits of the skin are registered only one member of the family.

Rupees 15000 rewards which would be provided to the successful candidates completions of the training

How to Register for Pradhan Mantri Vishwakarma Yojana

First of all one has to visit the website <http://pmvishwakarma.gov.in>.

After that applicant login CSC portal by entering his user id and password.

The applicant has to verify the account by entering his mobile number and Aadhaar card number, after that he has to upload the necessary documents and download the PM Vishwakarma certificate download option.

For PM Vishwakarma Yojana verification login the process of login is done through your gram panchayat or district officer who is.
